Current membership in the Wisconsin Hunter and Jumper Association is required in order to participate in the year-end awards program. Point accumulation begins on the date this application is received by the WHJA. *Points are not retroactive.*

- Each registered rider may earn equitation and medal points on only one circuit (A or Local).
- Each registered horse may earn hunter/jumper points on only one circuit (A or Local).

A registered rider and/or horse may switch circuits one time during the year, however, points accumulated for the new circuit begin as of the effective date of the change. Points are not retroactive. Any change in rider or horse membership status must be communicated in writing to WHJA.

Required for the rider's Equitation points and horse's Hunter or Jumper points to be counted toward year-end awards.
- (\$110) Family: Per Family and Two (2) Horses**
Only Immediate family members. Includes Amateurs & Juniors.
Points counted for those individuals and horses listed on this membership form.
- (\$140) Farm:** Two (2) Individuals (Pro or Amateur) and Four (4) Horses
Points are counted for the amateurs and horses listed on this membership form.
- (\$35) Additional Horse:** Per Horse
Required for the horse/pony's Hunter/Jumper points to be counted.
- (\$25) Supporting:** Mailing List inclusion ONLY. No voting rights
